GENERAL TERMS AND CONDITIONS

THIS AGREEMENT COVERS ONE (1) SYSTEM. IF THERE IS MORE THAN ONE SYSTEM AT THE RESIDENCE, COVERAGE MUST BE PURCHASED FOR EACH SYSTEM. THERE WILL BE NO REFUNDS ON SERVICE CONTRACTS. REPAIR & REPLACEMENT IS SUBJECT TO ALL CONTRACT TERMS AND CONDITIONS. REPAIR AND REPLACEMENT IS LIMITED TO THE PARTS LISTED & DOES NOT INCLUDE ANY PARTS RENDERED UN-FIT FOR USE IN THE EVENT OF FLOODED CELLARS, FIRE, FREEZING, OR CAUSES OTHER THAN NORMAL USE OF THE UNIT, OR LABOR ON SUCH PARTS. IT IS HEREBY AGREED THAT SERVICE SHALL BE RENDERED WITH REASONABLE PROMPTNESS, BUT IN NO CASE SHALL THE BUYER HOLD THE COMPANY RESPONSIBLE BECAUSE OF DELAYS IN RENDERING SUCH SERVICE BY REASON OF STRIKE, FIRE, ACCIDENTS, EQUIPMENT FAILURES OR ANY OTHER CAUSES BEYOND ITS CONTROL.

***PCD Heating is relieved of all responsibility for servicing of equipment. Any parts supplied by or labor provided by anyone independent of PCD Heating who performed work on the heating system. If this occurs, PCD Heating has the right to terminate the Service Contract. PCD Heating is not and will not be responsible for loss or damages due to or resulting from changes in oil consumption, improper operation of an attic fan or alternate fuel device, your failure to schedule maintenance, acts of God, terrorism, strikes, riots, material or labor shortages, fire, flood, accidents, abuse or misuse of equipment, spontaneous part failure. PCD Heating reserves the right to suspend service under or terminate this Agreement with or without notice and without further responsibility if you fail to make a payment on time or we deem your payment history unsatisfactory, you file for bankruptcy, you fail to remedy conditions identified as hazardous to life or property, you permit any person other than our authorized representatives to service your equipment, you fail to comply with your obligations under this agreement.

You are responsible for taking reasonable care and performing routine maintenance (i.e., operating system in accordance with manufacturer specifications) of your system.

You agree to pay the amount shown on each invoice in full. There will be a \$30 fee for all returned checks.

If we hire an attorney or collection agency to collect your outstanding balance, you agree to pay, in addition to your balance, all costs of collection, as permitted by law, including without limitation reasonable attorney's fees and court costs.
